Call to Order

Chairperson Thomas called to order the regular meeting of the D.C. Commission on Aging (“the Commission”) at 10:15 a.m., February 26, 2014 at 500 K St. N.E., Washington, D.C. 20002.

Inspiration

Chairperson Thomas provided the inspirational message and also thanked those in attendance for participating, notwithstanding the inclement weather conditions.

Presentations by Guest Speakers

Ms. Sally White, Executive Director of IONA Senior Services and Chair, Senior Advisory Coalition (SAC), reported on behalf of the Senior Advisory Coalition. She stated that the Senior Advisory Coalition has been effective in advocating on behalf of seniors, making valuable contributions to advocacy efforts that resulted in a \$7 million budget increase for DCOA to increase the number of social workers, eliminate wait lists for home delivered meals, and expand the availability of transportation services. She reported that SAC will continue to advocate for further increases to expand services to seniors in the District of Columbia. She also stated that SAC is advocating on other key issues such as the EPD Waiver program.

Ms. Gail Kohn, Age Friendly City Coordinator reported on the progress of the D.C. Age Friendly City Initiative. She reported that this important city-wide initiative is in the observation phase and will soon move into the planning phase. She stated that the first meeting of the Age Friendly City Task Force will be held on March 27, 2014, and that the first five domains of the Age Friendly City Initiative will be discussed. Ms. Kohn also stated that community

consultations are continuing, and that the need for housing options is a recurring theme in these discussions. She encouraged the commissioners to participate in the neighborhood walk-throughs and to also encourage the mini-commissions to participate in this process.

DCOA Update

Dr. Thompson reported on the DCOA white paper that discusses the need to revitalize and enhance DCOA senior wellness centers to meet the current and future needs of seniors in the District of Columbia. He reported that approximately \$16 to \$18 million is required to operate the facilities annually, excluding capital budget needs, and that this investment in senior health and wellness is necessary to keep seniors healthy and to prevent unnecessary hospital admissions. Dr. Thompson also reported that, as a result of recent budget increases, DCOA has purchased 39 additional busses to enhance transportation services available to seniors in the District of Columbia.

Committee Reports

- **Education and Employment:** Commissioner Willoughby asked for clarification of the role of the Education and Employment Committee, and the Commissioners discussed the Charter of the Education and Employment Committee that was approved in 2013.
- **Health and Wellness:** Commissioner Swanda reported that the Health and Wellness Committee is reviewing DCOA white paper on senior wellness centers, and he encouraged Commissioners interested in participating in this process to review and comment on this document.

Ward Reports

- **Ward 5:** Chairperson Thomas reported that she attended the DCOA Town Hall Meeting in Ward 5, and that the Ward 5 mini-commission continues to make progress with its efforts.
- **Ward 6:** Commissioner Colodny reported on a suspected incident of elder abuse in Ward 6, where a senior is receiving threatening telephone calls. It was agreed that this matter should be immediately reported to the police, if this has not already occurred.
- **Ward 8:** Commissioner Hair reported that the Ward 8 mini-commission will meet on March 10, 2014, and that Ms. Kohn will give a presentation on the D.C. Age Friendly City Initiative.

Adjournment

Upon motion and unanimous approval by the members of the Commission on Aging, the February 26, 2014 meeting of the Commission on Aging was adjourned at approximately 12:15 p.m.
